Notice: This program is available to:

1. Any and all residents over 18 years of age.
2. Any organization with adult supervision for those under 18 years of age.
3. Any business.
4. Any organization or service group

INSTRUCTIONS:

1. You must file this completed application and general release with the Town Clerk or the Town Supervisor. They will determine if the section of road is available.
2. After you receive confirmation that your adoption has been approved you must clean up the road before it can become official.
3. Once the road is cleaned you must notify the Highway Superintendent Bowman Owen (439-4213). His department will make an inspection.
4. The Highway Superintendent will present you application to the Town Board for final approval. Once approved by the Town Board, a sign will be erected and you will receive a certificate of adoption. If you desire to have your name or your organizations name on the sign, there is one time only charge of \$16.50.
5. You have adopted a road or a section (up to 2 miles) of a road for a period of 2 years. You have contracted to clean up your road at least 4 times a year.

6. The trash you pick up must be sorted in accordance with the County recycling regulations.
7. Disposal can be made at the County transfer station on Beaverkill Road in Livingston Manor. There is no cost for Adopt-A-Road trash. Your name will be provided to the county and you will have to verify your identity. If you intend to dispose of the trash through your commercial curbside pick-up, the choice is yours. So is the cost.
8. Please be careful walking the road as it can be dangerous out there.

Thank you for making the commitment to adopt a Town or County Road. The Town will be a better place to live.
