All sections of this bid must be completed and returned to the Town Clerk. The bid will be awarded as a whole, not individual units. The Town Board reserves the right to reject any and all bids submitted.

\*\* Pre-summer cleanup including removal of small brush prior to first mowing.

The following properties will be mowed & trimmed a minimum of once a week, in May, June and July (more if needed) - then as needed for balance of season. Every effort should be made to have the towns looking good for weekend visitors:

1. Exit 96 W -a strip along both sides of exit, including Caboose Area Around fishing parking lot, welcome sign & triangle w/chamber sign

2. Exit 96 E - both sides of exit & around Welcome sign.
