## **BWW Upward Brewery: Subdivision**

Jim Severing & David Walton of Upward Brewery presented updated site plan maps to the planning board, showing:

Total Acreage: 120.48 Acres - Lot 1 119.81 acres & Lot 2 0.52 acres

- ✤ Water & Sewer easements: 10ft wide pipeline from spring to house/ building
  - 50ft right of way for sewer uses/ drainage
- Utilities easements: formal use of the Gorr's underground electrical junction box
- Suilding Permits have been submitted to the Town's Building / Code Enforcement Dept.
- ✤ Short Form SEQR part 1 form submitted

Terms of the Map is missing graphic scales & small details

At the time of Engineering review of the Subdivision, discussion of the 280A wavier from the Town Board or ZBA was recommended. *After discussion with the Jim Severing and Vice Chairman Richard Barnhart for classification referred to the Cox Rd. subdivision: Parcels two (2) miles off the road / not attached to the subdivision with a right of way.* 

A motion was made by Richard Barnhart to make Town of Rockland Planning board the lead agency, motion was seconded by Ryan Edwards. The motion carried 6-0.

BWW Brewery will need to notify neighbors within 500 ft of the property via registered mail of the public hearing and submitted all postage to the Town of Rockland as proof of notice,

♦ A five hundred (\$500) dollar check was collected for the BWW brewery escrow account.
