Broadacres Farms / Livingston Farms - SBL 45.-1-1.1 :Special Use permit

Stefan Martinovic & Project Attorney John Cappello, along with Joseph Satto and John Bates presented the overall vision of the proposed project for Broadacres/ Livingston farms located on 26 Hoag Rd. . Livingston Manor, NY 12758. The parcel is also known as SBL #45.-1.1.1 The project is sponsored by Broadacre Farm Ventures, LLC, 25 Meadow Hill ,Armonk NY 10504

The project proposed a 15 lot subdivision and the construction of 9 residential homes with an agritourism operation including a regenerative two (2) acre farm, 42 unit campground , trail networks throughout property and hotel with restaurant and Guest house.
