• Presentation from Keiser Redevelopment Project - Pleasant Street

Michael Tucker representing the Keiser Redevelopment Presentation speaks upon the board of the future plans of this project. It is still undergoing zoning review, engineering and architectural planning. Plans are described to the board members and public explaining that this property will be made up of community spaces, 2 parks, parking spaces, a Japanese style restaurant, an open air market. These plans are projected to create a significant amount of jobs in the area, approximately 76 jobs. A sake brewery and tasting room is also in the plans as well as housing for the employees.
