Resolution #85 - 2025 Local Law #1 Flood Damage Prevention Law

PLEASE TAKE NOTICE that the Town Board of the Town of Rockland, in the County of Sullivan, State of New York, on July 17th, 2025, duly enacted Local Law No. 1 of the Year 2025, and entered it in its minutes.

Said local law repeals and replaces the Town's existing Flood Damage Prevention Law (Chapter 93 of the Code of the Town of Rockland) in order to update the same and incorporate therein the new Flood Insurance Study and Flood Insurance Rate Maps establishing the 100-year base flood elevations for the Town of Rockland as recently completed by the Federal Emergency Management Agency in order to maintain the Town of Rockland's eligibility to participate in the National Flood Insurance Program.

On a motion by roll call, this resolution was duly adopted.

- Letter from residents on Campsite Road about volume and speed with the traffic on that road. Letter was read aloud. Roger is contacting the Sheriffs department to see what can be done.
- Water customers from Junction in Roscoe came in response to Manganese "dirty water" letter– asked board members if the hydrant flushing can be done when the business is not in operation.

OLD BUSINESS

 66 Rockland Road 2 Bids have been received. Wittcon came in at \$369,000 and TAM at \$196,000

RESOLUTION #86 -2025 Pump station bids

A motion was made by Councilperson McRell seconded by Councilperson DeVantier with all in favor to move forward and hire TAM at the bid amount \$169,000. TAM will use equipment specified in the bid specifications for the Pump station repair.

• Pearl Street Parking Lot – Been surveyed, at least 18 cars can fit in the lot. Town has reached out to the DEC to discuss catch basins and will need to consider a dry hydrant in there for the fire department. The Town of Rockland highway department can do all this work. This nature of work may cost up to \$20,000, not to exceed \$25,000. The Town Board tabled this discussion until further notice.

RESOLUTION #87 -2025 Moratorium extension up to 6 months

A motion was made by Councilperson McRell seconded by Councilperson Edwards with all in favor to extend the moratorium an additional 6 months due to additional time needed to complete its work and make recommendations to the Town Board.

WHEREAS, the committee charged by the Town Board to evaluate and recommend revisions to the Town of Rockland's Comprehensive Plan, Zoning Law, Subdivision Law and other regulations in accordance with the purpose and intent of the Revised 2024 Town of Rockland Limited Land Use Moratorium has informed the Town Board that additional time is needed to complete its work and make recommendations to the Town Board; and

WHEREAS, the Town Board finds that it is in the best interest of the Town of Rockland to preserve the status quo and thereby prevent undermining the benefit of the prospective revisions to the Town's Comprehensive Plan, Zoning Law, Subdivision Law and other regulations by keeping in place the 2024 Town of Rockland Limited Land Use Moratorium until the Town Board is presented with recommendations as to any such revisions, and thus a necessity exists to extend the aforesaid moratorium for an additional period of six months pursuant to section 7 of the 2024 Town of Rockland Limited Land Use Moratorium.

NOW, THEREFORE, BE IT RESOLVED, by reason of the aforesaid finding of necessity, that the 2024 Town of Rockland Limited Land Use Moratorium be and hereby is extended for an additional period of six months.
