RESOLUTION #148 -2025 Approve Water & Sewer Rate Schedule for 2026

A motion was made by Councilperson Edwards seconded by Councilperson DeVantier with all in favor to approve the 2026 Water & Sewer Rate Schedule to increase: Roscoe Water to \$116.00 for minimum usage, Roscoe Sewer to \$151.00 for minimum usage, Livingston Manor Water to \$111.00 for minimum usage, & Livingston Manor Sewer to \$133.50 for minimum usage.

- New Accts for LMW and RW Construction for GIGP Grant match funds

RESOLUTION #149 -2025 New Accts For LMW & RW

A motion was made by Councilperson DeVantier and seconded by Councilperson McRell with all in favor to pass RESOLUTION to open and set up checking accounts for Livingston Manor Water Construction and Roscoe-Rockland Water Construction accounts putting GIGP grant match funds in these accounts. RESOLVED, that the Town of Rockland will open two checking accounts, Livingston Manor Water Construction Account and Roscoe-Rockland Water Construction Account putting the required local match amount for the GIGP Town of Rockland Water Meter Replacement Project. Livingston Manor Water Construction Account to open with a balance of \$120,000.00 and Roscoe-Rockland Water Construction Account to open with a balance of \$80,000.00 moving the money from fund balance savings.
